Alcoholic Beverages are prohibited in booth. Consumption of alcohol before or during festival hours by food vendor participants and all staff members is prohibited.

NO drug related items to be sold or brought onto the Kern County Fair premises. There is a zero tolerance for this condition. A violation of this condition will result in immediate removal from the show and NO refund will be given.

REFUND POLICY: No Refunds due to bad weather or acts of God. Refunds will be made

ONLY if a written request is received two weeks prior to the event. A cancellation fee of \$75.00 will be deducted from all refund checks.

All vendors and participants MUST provide Proof of General Liability Insurance to participate in the Bakersfield Wing Festival.

Certificate of Insurance must include personal injury and property damage liability insurance with a minimum coverage of \$1 million for each occurrence.

In addition to the statement of insurance coverage, the Kern County Fair needs to be named as additional insured.
